- * Car Show move-in time on Sunday, September 29: 11:00AM until 12:45PM
- * Hours for car show: 1:00 until 4:00PM. (All cars must be in place no later than 1:00 due to other activities on the show grounds.)
- * Move-out time: 4:30 until 6:00PM. (To ensure safety, cars are not permitted to move during car show hours without permission from the car show chair or the fair superintendent.)
- * Pre-registration fee: \$15.00 Pre-registrations must be postmarked by September 25st. (Late Registration is also available at the gate \$20.00.) Registrations will not be counted until fees are received. Dash Plaques will be given to the first 100 registered.

Small sun canopies will be allowed behind each car if desired. Food vendors will be on hand during all show hours. No alcohol allowed on the fairgrounds on Sunday.

Trophies and prizes will be awarded at 4:00PM. AWARDS WILL BE GIVEN TO TOP 20, BEST MODIFIED, BEST ANTIQUE, AND AN AWARD SELECTED BY THE CHAIRMAN OF THE COUNTY FAIR.
